

PRIVACY POLICY

GENERAL MATTERS

Overview

At Oleon, protecting our users' privacy and security is a top priority. For this reason, we have adopted the following policy to advise you of your choices regarding the use of your personal information online. This policy describes what types of information we gather about you, how we use it, under what circumstances we disclose it to third-parties, and your rights to update or correct it.

Scope of Policy

This Policy applies to Oleon.com. It does not apply to other companies' or organizations' web sites to which we link.

INFORMATION ABOUT YOU

Information Gathered From All Visitors

- **Aggregate Data:**
We gather certain generic information with respect to customers' use of our web site, such as the number of unique visitors, the frequency with which they visit, and the areas on the web site that they favor. We only look at the data on a collective basis, in summary form, rather than on an individual basis. These statistical ratings do not contain any personally identifiable information about you or any of our users.
- **IP Addresses:**
We collect and analyze traffic on our web site by keeping track of the IP addresses of our visitors. We log this information so that we can monitor things like the number of visitors visiting the web site; however, we do not link your IP address to any personally identifying information.

USES OF PERSONAL INFORMATION

When you do provide us with personal data, we may use that information in the following ways, unless stated otherwise: we may store & process the information to better understand your needs and how we can improve our products and services. We (or a fulfillment house or other third party on our behalf) may use that information to contact you. We do not now and do not intend to sell, rent or market personal data about you to third parties. We will not make your e-mail address available to other parties. However, in the future we might occasionally send you e-mails about new services. If that were to be the case, you will have the explicit option to indicate that you prefer not to receive any e-mails from Oleon in the future.

Access to and correction of your data:

We fully respect the Belgian Act of 8 December 1992 on Privacy Protection in relation to the processing of Personal Data.
